# WHO WE ARE

---

Health Ministries Network (HMN) is a Washington State 501(c)(3) Nonprofit Health Advocacy Corporation affiliated with Chuckanut Health Foundation, Bellingham WA.



Over 20 years HMN has grown to include 130+ Faith Community Nurses and Health Ministers who serve in 80+ congregations and community organizations that are mostly located in the Skagit, Whatcom, Islands and San Juan counties of Western Washington.

HMN is also affiliated with the national organization of Faith Community Nursing/Health Ministry through the Westberg Institute and the Church Health Center in Memphis Tennessee.

Faith Community Nurses (FCNs), also known as Parish Nurses (PNs), are recognized by the American Nurses Association as a specialty professional nursing practice area.

Health Ministers (HMs) work with FCNs to serve those in need of support and a healing presence.

# WHAT WE DO

*Faith Community Nurses and Health Ministers . . .*

. . . show the love of God through the promotion of mind-body-spirit wellness. These caring people provide services without charge to facilitate healing for individuals and groups in roles such as . . .



- **Health Advocate** who encourages healthy habits and diet choices, offers topical presentations and health related small group discussions.
- **Personal Health Counselor** who monitors blood pressures and consults with clients to understand their health care needs.
- **Advisor** who makes home visits, offers referrals to essential services, helps with medical equipment, and works with clients to prevent falls.
- **Spiritual Partner** who listens actively, supports spiritual needs and (with permission) prays with individuals and families.
- **Health Transition Services** help manage medications, observe for warning signs of worsening condition, accompany clients to follow-up appointments, and help clients maintain a health record



# FOUNDATIONAL

---

FCNs and HMs complete a rigorous 38-hour Foundational Preparation Course by Westberg Institute. This program combines face-to-face interaction and on-line course work designed to prepare FCNs and HMs for holistic health advocacy in their congregations or organizations.

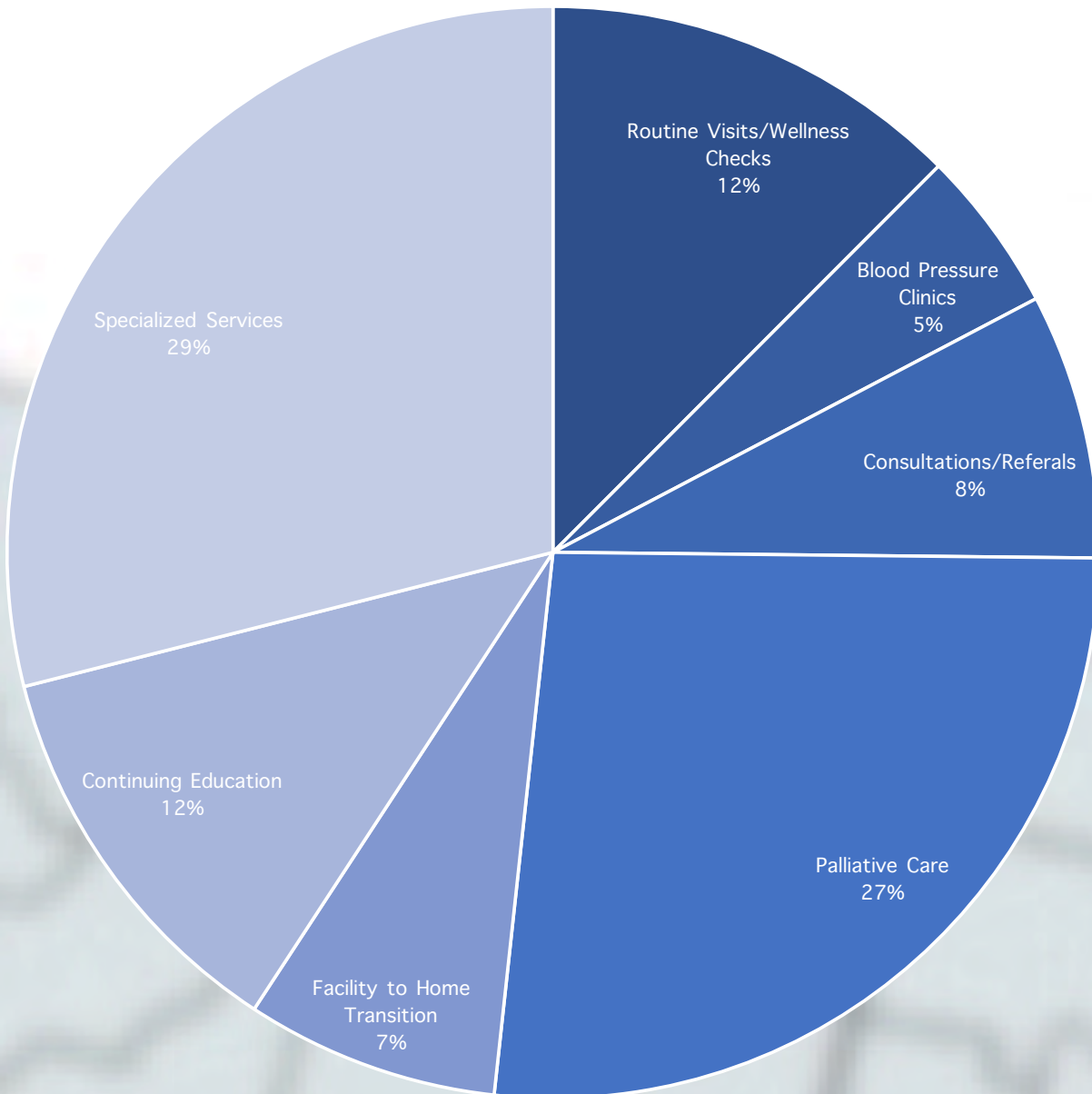
How we determine our contribution . . .

This categorized data is used to estimate the number of individual hours of service and ultimately, the Health Ministries Network total annual aggregate contribution.

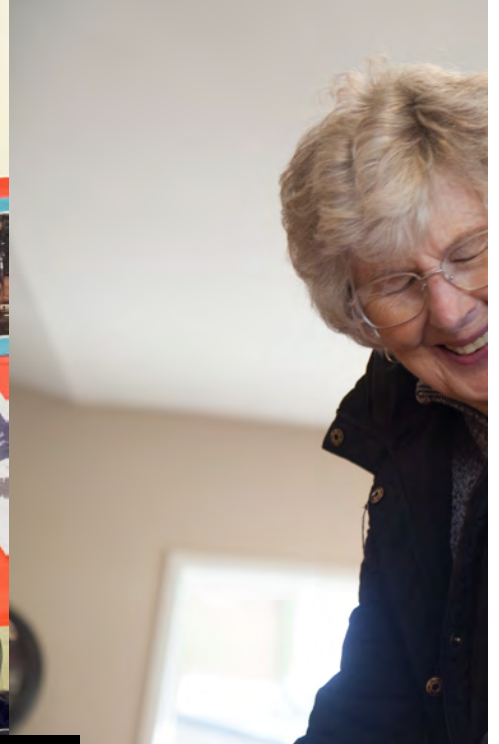
